1. PROJECT OBJECTIVES

This initiative is promoted and executed by the Italian Ministry of Universities and Research through the National Recovery and Resilience Plan (NRRP) to develop Transnational Education (TNE) and formally funded by the European Union – NextGenerationEU within the framework of the NRRP – Mission 4 "Education and Research" – Component 1 "Enhancement of Education Services: from Nursery Schools to Universities, from Research to Business" – Investment 3.4 "University Teaching and Advanced Skills" T4 "Transnational Initiatives in Education" – CUP F91B24000320006. The Polytechnic University of Bari – Italy, implements this by announcing mobility programs and grants for study periods, specifically during the first semester of the 2025–2026 academic. The general objective is to build a consortium of Italian universities that export best practices in higher education to East Asia and the Western Balkans through the unifying theme of health, adopting a "One Health" approach that links human, environmental and animal well-being. Specifically, the project TNE23-00059 "Health Education and Advanced Learning Through Collaboration, Opportunities, Networking, and Educational Connections in Balkans and Asian Countries -HEALTH-CONNECT" aims to:

- **transnational cooperation** strengthen academic collaboration in health education across Italy, the Balkans and East Asia
- **one health perspective** integrate health, environment and sustainable development into education and research
- advanced learning & green technologies develop curricula, joint degrees and mobility programs focused on green strategies, digital innovation and circular economy for health and well-being
- work package 3 "Health and Inhabiting" explores health in relation to architecture, cities and landscapes (urban well-being, inclusivity, regeneration)
- work package 6 "Health and Development"— focuses on sustainable technologies and green innovation for health and development

The mobility period must take place exclusively during the first semester of the 2025–2026 academic year and must be completed by March 31, 2026.

Pursuant to the exchange agreements, students from partner universities (e.g., SCUT) attending the Polytechnic University of Bari – Italy, for a portion of their studies are guaranteed full academic recognition of all successfully completed work by their home institutions.

The release of the financial grant is strictly dependent upon providing proof of ONE of the following requirements:

Credit Recognition: the student must successfully acquire curricular credits (ECTS or equivalent) at the Polytechnic University of Bari – Italy, that are officially recognized by their Home Institution OR









Activity Certification: the student must submit a certificate from their Home Institution confirming that the completed study activities align with the TNE program.

3.1 Disbursement Rules

The grant for general expenses will be paid as a lump sum upon the signing of the contract, up to a maximum amount of €3,000.00. Any monthly allowance exceeding this maximum amount shall be borne entirely by the student.

3.2 Account Holder Requirement

Reimbursements will only be made to bank accounts held in the name of the mobility contract holder. No payments will be processed to accounts registered to any third-party including relatives or delegates.

3.3 Travel Reimbursement Procedure

The contribution for airfare will be reimbursed up to the maximum amount as detailed in the table above (€1,200.00). Any costs exceeding this limit will remain at the student's expense. The reimbursement will be processed upon submission of proof of purchase, and at the signing of the contract. To this end, selected students must send the following documents to: tne-arcod@poliba.it

- Payment Receipt
- Copy of the Purchased Airline Ticket

3.4 Penalties and Grant Recalculation

In case of withdrawal, termination, or revocation of the mobility, or if the period of stay in Italy is shorter than one full month, the student will be required to return the full amount of the grants already received. If the period of stay is shorter than the duration specified in the contract, but still exceeds one full month, the total contribution will be recalculated based on the actual duration of the mobility. Any excess amount previously received will have to be refunded by the student. Definition of Duration: for calculation purposes, each month is considered equal to 30 days, regardless of the specific calendar month.

4. GRANTS DISBURSEMENT

Incoming students selected for mobility at the Polytechnic University of Bari – Italy, will receive a **mobility** grant financed under the NRRP TNE23-00059 "Health Education and Advanced Learning Through Collaboration, Opportunities, Networking, and Educational Connections in Balkans and Asian Countries – HEALTH-CONNECT" – Project CUP F91B24000320006.









The financial contribution is intended to **partially cover** the travel and living expenses incurred during the study period in Italy.

4.1 Conditions

The disbursement of the financial contribution is strictly subject to the fulfillment of the following three conditions:

- The signing of the Learning Agreement prior to the student's arrival in Bari
- The **actual arrival and registration** at the Polytechnic University of Bari Italy, confirmed by the official Arrival Certificate
- The completion of all planned academic activities

Important Note → Failure to complete the required activities or the early interruption of the mobility period may result in the **partial or total withdrawal** of the financial contribution.

4.2. Student Financial Responsibility

Each student selected to participate in the Extra-EU TNE exchange program is solely responsible for covering all personal expenses, including:

- Board and lodging
- Purchasing travel and health insurance valid for the entire mobility period
- Any additional costs that may apply to international students, such as fees related to sports activities
 or other optional services offered by the Polytechnic University of Bari Italy

5. WITHDRAWAL FROM THE MOBILITY PROGRAMME

Should a selected student wish to withdraw from the assigned mobility for any reason, they **must promptly communicate** this decision via email to **tne-arcod@poliba.it**

In the event of a withdrawal, the administrative offices will proceed immediately to contact the next eligible candidate on the relevant ranking list.

6. ELIGIBILITY REQUIREMENTS

6.1 Selection Process and Ranking

The selection process will be carried out by a Selection Committee formally appointed by the Rector's Decree. The Committee's decisions are **final and not subject to appeal**. A specific **Ranking List** will be drawn up for each mobility destination. Candidates will be awarded a mobility grant based on their position in this merit list.

6.2 Academic Evaluation Deadline

The definitive reference date for the evaluation of academic achievements is 28th November 2025.

Important Note → For the purpose of academic assessment, only examinations and learning activities completed and officially registered by the Home University by this deadline will be considered valid. It is the applicant's sole responsibility to ensure all valid exams and grades are correctly registered by their institution by this date; under no circumstances will unrecorded exams be taken into consideration.









7. ELIGIBLE MOBILITY ACTIVITIES

During the mobility period at the Polytechnic University of Bari - Italy, selected students may carry out the following academic and professional activities:

- Thesis Preparation: subject to the approval of the Supervisor at the Home Institution and the availability of an Academic Tutor at the Polytechnic University of Bari Italy
- Internship or Traineeship: subject to the availability of placements and the approval of both the Home Institution and the Polytechnic University of Bari Italy
- **Tutoring Activities:** to be carried out under the direct supervision of an Academic Tutor at the Polytechnic University of Bari Italy
- Research Activities: to be carried out under the direct supervision of an Academic Tutor at the Polytechnic University of Bari - Italy

Final Deadline

All approved mobility activities must be completed no later than 31 March 2026.

8. APPLICATION PROCEDURES AND DEADLINES

Optional, but preferable: an international English-language certificate

For the purposes of eligibility and academic evaluation, only the exams and academic activities completed and officially recorded by the home university by **28th November 2025** shall be considered valid. It is the applicant's responsibility to ensure that all relevant exams are duly registered and certified by their institution by that date.









9. SELECTION CRITERIA

The ranking will be based on the following criteria, adding up to a maximum of 100 points **for PhD students only** & 50 points **for all other students**:

Criteria	Maximum Points	Notes
Study / Research Program	20 points	relevance of the proposed plan for activities at the Polytechnic University of Bari - Italy
Motivation Letter	20 points	quality and persuasiveness of the letter
Language Proficiency	10 points	based on certified language proficiency
Academic Merit	CV / weighted grade point average (GPA)	For PhD students only: academic Curriculum (up to 50 points) For all other students: weighted grade point average (GPA) officially recorded by the home University at the deadline

Important Note → For PhD students only: in the event of equal overall scores, the tie-breaking criterion will be an evaluation of the curriculum vitae (CV) including publications and any other relevant qualifications. For all other students: in the event of equal overall scores, the tie-breaking criterion will be the weighted academic grade point average (GPA). Preference will be given to the candidate with the higher weighted average.

10.MANDATORY REQUIREMENTS

10.1 Before arrival:

- Promptly complete all documentation required for the disbursement of financial contributions
- > Sign the Learning Agreement with the Polytechnic University of Bari Italy
- Sign the contract

10.2 Upon arrival at the Polytechnic University of Bari - Italy:

Upon arrival, the hosting Department ARCOD will issue an arrival certificate.

Non-EU students must apply for a Residence Permit (Permesso di Soggiorno) within 8 working days of their arrival in Italy. This is done by completing and submitting a specific application kit (Kit Postale) at an authorised post office









10.3 At the end of the mobility and before departure:

At the end of the mobility, the hosting Department ARCOD will issue a **Certificate of attendance** and activities carried out at the Polytechnic University of Bari - Italy, indicating the actual dates of stay (for credit recognition by the home university and for grant settlement)

11.MEDICAL, LIABILITY and TRAVEL INSURANCE

11.1 Coverage Provided by the Host Institution

All students participating in the Extra-EU exchange program are automatically covered by the Polytechnic University of Bari - Italy's insurance policy for **accidents** and **third-party liability** while engaging in official academic activities on university premises.

11.2 Mandatory Travel Insurance

However, **each participant is required** to purchase, at **their own expense**, comprehensive **travel and health insurance** valid for the entire duration of the mobility period.

This mandatory policy must specifically include coverage for:

- Temporary or permanent disability
- Serious illness
- Repatriation of remains in case of death

Such insurance may be obtained through private schemes or policies, in compliance with the specific requirements of the student's home country or the regulations applicable to foreign students in Italy.
